- PSAB's strength lies in the unity of our diverse communities





Thomas F. Chrostwaite was the driving force behind PSAB for almost half a century. PSAB continues to offer legislative representation, advocacy, information, and education – all of which remain the core pillars of our foundation.

Although the scope of services provided to our membership has evolved over time from those first offered in 1911, the focus of the Association has been – and continues to be – advancing the interests of boroughs while providing tools to help officials effectively govern.



Research and Technical Assistance

Each year, thousands of officials contact the Association to ask questions about the Borough Code, Sunshine Act, employment issues, Open Records, meeting management, and so much more. In 2023, the Research Department was proud to help you navigate remote meeting governance and transparency, emergency declarations, and much more. In all, the Research Department fielded more than 2,000 inquiries over the past year.

Many frequently asked questions from the membership also appear in the Question & Answer column of the *Borough News* each month to help other officials too.

PSAB also produces the online Budget Bulletin, a resource that can help you navigate the borough's fiscal process, and includes a budget calendar, tax structure, and key state reporting deadlines. This information can also be found in the Borough Planner & Calendar and on boroughs.org.

Education and Professional Development

It was another busy year of PSAB training in 2023. Over the course of the year the training department continued to strive to meet its goal of providing relevant and accessible training and educational programs for municipal officials. Our training was provided through a combination of partnerships with local government professionals, subject matter experts, state and federal agencies, and PSAB staff. Training was offered in a variety of modes—online and in-person—and formats—full-day, hour-long, 90-minute, multi-part—designed to accommodate the busy schedules of municipal officials.

For the year, PSAB had more than 4,500 municipal officials register for its training.


In 2023, PSAB continued its partnership with the PA Municipal Planning Education Institute (PMPEI) to provide learning opportunities on zoning, planning, and land development review. PMPEI offers a variety of planning and zoning courses both online and in-person. The department administered over 35 PMPEI courses throughout 2023.

Throughout the year, borough officials continued seeking out opportunities to earn the Certified Borough Officials (CBO) designation, which is a voluntary educational achievement program for both elected and appointed borough officials. The program is designed to promote continuing education for borough officials and excellence in local government service. Twenty-nine borough officials earned the CBO designation in 2023 and many of these recipients were recognized at the Association's annual conference.

PSAB was also proud to continue the PSAB Plus Training Subscription Program in 2023.

PSAB members that elect to enroll in PSAB Plus get free access to all PSAB webinars and a 50 percent discount on all traditional classroom and online course training. This program continues to grow in popularity for boroughs looking to invest in training and education.

2023 Legislative Advocacy

Since 1911, advocacy has been critical to the mission of PSAB. Mr. Chrostwaite, in his creation of the organization, described the ability of an association to speak with one voice and exert collective influence on the General Assembly as a key benefit of membership. PSAB is the official instrument through which borough officials should make their needs known to Congress and the Pennsylvania General Assembly, and in turn, the formal spokesman to which the state and federal governments and their legislative bodies look for the official expression of those needs. The PSAB Department Government Affairs has sought to preserve, promote, and advance legislation and public policy in the best interests of the Commonwealth's borough communities.

2023 was as tumultuous of a year in the Pennsylvania General Assembly as ever. From a new Democratic Majority in the House of Representatives for the first time since 2010, to a new Governor taking office with an overwhelming victory in the previous election, there were many changes to the status quo in Harrisburg and created a very slow start to the legislative session. In fact, just over half of the 66 bills the General Assembly passed this calendar year were signed into law between December 11th and 13th.

Even amidst the slow start to session, PSAB was able to advocate and gain legislative victories in different areas of the law including:

- Act 10 of 2023 This Act gives the Municipal Police
 Officers' Education and Training Commission statutory
 authority to conduct fingerprint-based criminal history
 checks on municipal police officer applicants to ensure that
 municipalities are accepting and training qualified individuals.
- Act 15 of 2023 This Act addresses the needs of the EMS community by increasing reimbursement rates for services and ensuring providers are compensated for all loaded miles. Act 15 will drive \$63.1 million in new revenue and new resources into the EMS network statewide beginning January 1 through the end of the 2023-24 Fiscal Year (or \$126.2 million on a full-year basis).
- Act 34 of 2023 This Act was the budget implementation vehicle for the Fiscal Code. Included in this bill is the reauthorization of funding for county 911 systems. Beginning March 1, 2024, the 911 surcharge will increase to \$1.95 from the \$1.65 from the previous budget.

As this was the first year of the two-year legislative session, PSAB has advocated on many other legislative matters that we hope to get across the finish line this session including:

- **HB 1567** (Rep. Malagari) This bill would permit tenants who are currently residing in a property to remain in the property, dependent on the property's safety and habitability and approval of the municipal code enforcement officer.
- **SB 459** (Sen. Rothman) This bill would give municipal police the use of radar to enforce the maximum speed limits on local roads. *Resolution 2022-12*

- **HB 1207** (Rep. Freeman) This legislation would remove the minimum population requirements to create a land bank, allowing all municipalities, including smaller municipalities, to establish land banks on a voluntary basis. *Resolution 2021-04*
- HB 1232 (Rep. James) This bill would make four changes to the borough code including changes such as: adding language providing that an elected or appointed official of a borough may not be surcharged if the official acting in good faith on a written or publicly-disclosed opinion of the borough solicitor, authorizing a borough to appoint a partnership, limited partnership, association or professional corporation as the borough manager, permitting the civil service commission of a borough to reorganize within 30 days of the first Monday in January of each even-numbered year, and removing a requirement that a preliminary budget be prepared beginning at least 30 days prior to the adoption of the budget.
- **SB 501** (Sen. Baker) This bill would allow for the creation of county-wide Public Safety Authorities for EMS services. *Resolution 2023-14*
- **SB** 753 (Sen. Kearney) The legislation provides for the reduction of council membership from 7 to 5 or 3 members regardless of borough population, and conversely increase council size, repeals current provisions in the Borough Code regulating the accumulation and collection of garbage and other refuse materials and creates a new chapter 25B "Solid Waste Collection and Disposition.

Over the next year, PSAB will continue our efforts advocating for the issues of the utmost importance to our members which include:

- Requiring PennDOT to pay and maintain stormwater facilities on state highways in boroughs.
- Authorizing local police officers to use radar and lidar to enforce the speed limit.
- Addressing reforms to the Motor License Fund recognizing unique municipal needs.
- Reforming the Policemen and Firemen Collective Bargaining Law (Act 111) to ensure communities can afford public safety services.
- Increasing the maximum allowable compensation for council members and mayors in boroughs.
- Eliminating the public notice provision requiring advertising in newspapers of general circulation.
- Amending Act 65 to add statutory protection to the "catch-all" provision allowing any item to be added to an agenda by majority vote, which was overturned by the Commonwealth Court.
- Repeal the archaic civil service mandates in the Borough Code, which complicate the hiring process of borough police.
- Increasing the Prevailing Wage threshold.

Programs & Membership Resources

Borough Elected Officials Program (BEOP)

Provides up to \$10,000 in term life and accidental death and dismemberment insurance for borough elected officials; up to \$2,000 spouse coverage; and up to \$1,000 for each dependent. The program is provided through Keystone, PSAB's endorsed insurance provider, and underwritten by Guardian Life.

Borough Management Caucus (BMC) Program

Provides up to \$5,000 in term life and accidental death and dismemberment insurance for the borough manager/appointed administrator and/ or secretary. The program is provided through Keystone, PSAB's endorsed insurance provider, and underwritten by Guardian Life.

Employee Drug and Alcohol Testing Program (DOT/CDL & Non-DOT/Non-CDL)

Provides all the DOT/CDL drug and alcohol testing required by federal and state law, including random, pre-employment, post-accident, reasonable suspicion/cause, return-to-duty, and follow-up testing. This program is administered through Vault Health, PSAB's endorsed testing provider.

Energy Procurement Program

Provide data-driven procurement solutions that reduce and manage electricity and natural gas supply costs for members on an ongoing basis. It includes free analyzation of energy costs; evaluation of current supply contracts; and proprietary price analytics. This program meets the exemption from typical bidding requirements found in the Borough Code. This program is offered through APPI Energy, PSAB's endorsed energy provider.

Junior Council Person Program (JCP)

Engages youth in borough government and provides mentoring opportunities through public engagement, meeting management, team building, and collaboration. PSAB also recognizes Junior Council Person(s) by presenting them with a Distinguished Junior Council Person Award.

Keystone Municipal Insurance Program

Offers workers' compensation and property and casualty insurance. The program is provided through Keystone, PSAB's endorsed insurance provider.

Keystone Municipal Insurance Trust (KMIT)

Provides a competitive self-insured workers' compensation alternative for municipalities and authorities. It offers access to professional risk improvement services to increase workplace safety. The program is administered by the Kilmer Group, and provided through Keystone, PSAB's endorsed insurance provider.

Municipal Retirement Trust (MRT)

Specializes in full-service municipal pension planning. This program offers superior customer service, affordable fee structures, and impressive rates of return.

Pennsylvania Local Government Investment Trust (PLGIT)

Owned and operated by participants, PLGIT is a short-term investment option with a number of convenient cash management services that exclusively serves more than 3,000 local governments and other types of governmental agencies in PA. PLGIT is the endorsed investment provider for PSAB members.

Procurement Card Program (P-Card)

Allows boroughs to maintain control of spending to manage municipal finances more effectively. There are no annual fees or revolving lines of credit. The program is offered through PLGIT, PSAB's endorsed investment provider.

Special Event Liability Insurance

Provides special event coverage for parades, festivals, & other events and includes optional weather insurance, event cancellation, and prize indemnity insurance. The program is provided through Keystone, PSAB's endorsed insurance provider, with Tokio Marine HCC as the underwriter.

The Employment Alliance of Municipalities (TEAM)

Provides legal advice on labor and employment issues including eight free non-complex telephone or email sessions each year. A credit of up to \$150 on PSAB online labor and employment law training; Services are provided by Eckert Seamans, PSAB's endorsed provider.

Unemployment Compensation (UC) Plan

Offers full-service administration and claims management of UC activity, lower contribution rates, and hearing representation and/or consultation, and secure online reporting.

Provides a low-cost program to help your municipality develop and gain a basic online presence.




Mayor of the Year Award
